

Artemis Therapeutics, Inc. Privacy Policy

Artemis Therapeutics, Inc., (“Artemis”, “we”, “us”) recognizes the importance of protecting the privacy of information we may receive from visitors to our website (this “website” or the “site”). This Privacy Policy describes the information we collect from visitors to this website, how we may use it and with whom we may share that information, the safeguards we use to protect such information and the choices you may make with respect to your personal information.

Information We Collect/Information We Collect Automatically

You may visit our website without telling us anything about yourself or providing any personal data. Please be aware that we automatically collect certain information about visitors to this website, including the Internet Protocol (IP) address of your computer, browser type, date and time of your visit, how long you visited certain pages on the site, and the page or service you are requesting. We may use aggregate and/or de-identified data about visitors to our website (“Aggregate Information,” or “AI”) for various business purposes, including:

- (i) enabling users to log-in into the Site;
- (ii) administering use of the Site, including, but not limited to, communications at the email address provided during registration to provide notification regarding the Site, such as any future amendments to its privacy practices or this Privacy Policy;
- (iii) ensuring all users follow our Terms and Conditions and other rules and policies;
- (iv) banning a User temporarily or permanently for failure to follow our Terms and Conditions, rules and policies, or for other misconduct or inappropriate behavior;
- (v) responding to questions and comments from users;
- (vi) providing users with newsletters, updates, and other materials related to the purposes of the Site, or with information or offers from us or third parties that we believe users may find useful or interesting;

- (vii) monitoring and analyzing the Site (including, but not limited to, measuring users' interest in and use of various areas of the Site);
- (viii) improving the functionality, design and quality of the Site;
- (ix) performing the technical administration of the Site;
- (x) investigating cases of suspected abuse or fraud;
- (xi) preparing statistical and other summary analyses of our users' behavior;

(Collectively, "Our Business Purposes").

When a user uses a widget or any other tool offered by us, whether on the Site or on a third party website, including a website owned or operated by a user, we may record data related to that activity, the deployment of the widget or tool, and any other account related data

Artemis has constructed this website so that you may visit us and review information about our company and our products without revealing your identity or volunteering any personally identifying information. If you choose to register to use features and services of this website, either as a consumer, an investor or a healthcare professional, we will collect "personally identifiable information" ("PII") from you, such as that indicated above, and this information may be combined, to provide you with services or information you request or to ensure that we maintain complete, current and accurate personal information.

Cookies

This website deploys cookies. These are small text files that this website places on your computer or other Web-accessing devices. These cookies allow us to distinguish you from other users of this website, and to enhance this website and your experience when you browse it. We also collect information about your use of this website through cookies and similar technology. Cookies allow us to recognize you and maintain your preferences when you return to this website. Cookie technology collects "clickstream" data, which do not include personally identifying information, but which reflect your activities on this website and help us to improve the site and anticipate what may be of most interest to our users, by monitoring traffic in popular areas and modifying the services and information to meet demand. We use cookies on this website to (i) direct users to the relevant sections on the site, (ii) ensure the site delivers a consistent look across

different browsers and devices, (iii) enable complex areas of the site to function, (iv) to track aggregated statistics about visits to the site to help us improve site performance.

We only use first-party cookies and we do not allow other sites or third parties to use our cookies for their own purposes or to place their own cookies on your computer when you access this website.

Most Web browsers allow control of cookies through the browser settings. You can set your browser to notify you when you receive a cookie, which will enable you to decide if you want to accept it or not. However, if you do not accept a particular cookie, certain elements of the site may not function correctly or completely.

Information You Provide Through the Site

If you contact us and choose to provide PII or other personal data, such as your name, address, telephone number or email address, we will utilize it for the purpose for which you submitted it to us, such as to respond to your inquiry or to provide you with the information you have requested, or for any of Our Business Purposes. We do not collect or maintain PII for resale purposes, or share your information with any other company or organization, except as indicated above or to the extent such other company or organization is acting as our agent for processing or mailing purposes to assist us in providing information that you have requested. In addition, we will not send unsolicited messages to users of our site who indicate that they do not wish to receive such messages. Do Not Track Disclosure

We do not track our users over time and across third party websites to provide targeted advertising. We therefore do not respond to Do Not Track (DNT) signals. If for any reason a court of competent jurisdiction finds any provision or portion of this Privacy Policy to be unenforceable, the remainder of the Privacy Policy will continue in full force and effect.

Your Privacy Choices

If an individual becomes aware that personal information we maintain about them is inaccurate, incomplete, misleading, irrelevant or out of date, or if an individual would like to access, update or review his or her information, the individual may contact us using the contact information below. Artemis will attempt to provide the requested information or make requested changes to the extent allowable by applicable privacy laws. In any event, we will respond to you as soon as reasonably possible to advise you of the outcome of your request. You may request the removal of previously provided personal information at any time
